AFFIDAVIT OF COMPLIANCE: Holding Estate Sale (Requires signatures from both the homeowner and the owner of the company conducting the estate sale)

1. If you anticipate between 20 to 35 vehicles parked on the street at any given time, a parking attendant is required. For every 35 vehicles thereafter, an additional parking attendant is required. These parking attendants are there expressly to monitor the parking situation and may not be commissioned to aid the customers with they carry-out of their purchases.
2. The estate sale cannot extend beyond the Friday evening, Saturday and Sunday event.
3. If you have asked your patrons to return at a later date to pick up goods and you anticipate more than 10 vehicles that day, you must notify city hall with a special request to do this as this is a violation of Home Occupancy rules.
4. If you anticipate between 20 to 35 vehicles parked on the street at any given time, the neighbors must be notified with a simple brochure, email, door hanger, flier, etc. alerting them of this sale. In this way, the residents have the opportunity to alert their landscapers, deliveries, guests they will be entertaining, etc. of this potential parking issue on their street(s).
5. If you begin the sale before the end of the school day on Friday, the bus company must be notified along with those parents that would be affected.
6. Alert all potential customers their vehicles will be towed if they block a mailbox; driveway, fire hydrant, or are found to be parked at any place where official signs prohibit parking. Further infractions that would warrant citations and/or towing are as follows: parked within fifteen (15) feet of an intersection; within eight (8) feet of a public U.S. mailbox; within eight (8) feet of a mailbox located on or at private property between the hours of 8:00 a.m. and 5:00 p.m. except on Sunday and Federal holidays. Additionally, no vehicle can park any closer than 5' from either side of any given driveway.

The joint holders of the Estate Sale (homeowner and the owner of the company conducting the estate sale) agree to comply with the above requirements. If we find any variances to the aforementioned, Clarkson Valley has the right to immediately halt the sale.
